"Dear Shareholder/Investor

This is being addressed to our esteemed investors in view of the sustained selling witnessed in our counters yesterday. We wish to highlight the following facts and request you all not to panic and lose money.

Your Company's performance in the past 4 years has been witnessed by you. The Company is in the pink of health and we are doing extremely well with very aggressive and achievable business plans. We wish bring the following facts to your knowledge in case you are not aware:
